# CONDITIONS OF SALE

ORDERS ARE SUBJECT TO ACCEPTANCE BY HUTTON COLLECTIONS.

ORDERS ARE CONSIDERED ACCEPTED ONLY AFTER HUTTON COLLECTIONS ISSUES A WRITTEN AND DATED ORDER CONFIRMATION.

ACCEPTANCE OF AN ORDER IS BASED ON THE EXPRESS CONDITION THAT THE PURCHASER AGREES TO ALL OF THE TERMS AND CONDITIONS DESCRIBED HEREIN. PAYING A DEPOSIT ON AN ORDER BY PURCHASER WILL CONSTITUTE ACCEPTANCE BY PURCHASER OF THESE TERMS AND CONDITIONS.

WE HEREBY EXPRESSLY REJECT ANY AND ALL TERMS AND CONDITIONS OF ANY PURCHASE ORDER SUBMITTED TO US. ALL TRANSACTIONS ARE MADE ONLY ACCORDING TO THE TERMS AND CONDITIONS DESCRIBED HEREIN. THESE TERMS AND CONDITIONS CAN NOT BE MODIFIED WITHOUT THE WRITTEN CONSENT OF HUTTON COLLECTIONS.

HUTTON COLLECTIONS RESERVES A PURCHASE MONEY SECURITY INTEREST IN MERCHANDISE COVERED BY THIS CONTRACT UNTIL FULLY PAID WITH ALL RIGHTS OF A SECURED PARTY UNDER THE DELAWARE UNIFORM COMMERCIAL CODE.

#### PRICES AND TERMS

HUTTON COLLECTIONS RESERVES THE RIGHT TO CHANGE PRICES WITHOUT PRIOR NOTICE. QUOTATIONS ARE HONORED FOR A PERIOD OF 30 DAYS. A MINIMUM DEPOSIT OF FIFTY PERCENT (50%) OF THE PURCHASE PRICE IS REQUIRED TO INITIATE ORDER FULLFILMENT. ORDERS FOR TEXTILE AND IN STOCK PRODUCTS REQUIRE PAYMENT IN FULL TO INITIATE ORDER FULLFILLMENT. IN THE EVENT THAT THE FINAL BALANCE IS NOT RECEIVED WITHIN 30 DAYS FROM THE DATE OF THE FINAL INVOICE PURCHASER AGREES TO PAY A STORAGE PENALTY ON THE UNPAID BALANCE AT A RATE OF 1.5% PER MONTH (18% APR). ALL ORDERS MUST BE PAID IN FULL, INCLUDING SHIPPING, HANDLING, PACKAGING/IMPORT, STORAGE, TAXES AND SERVICE CHARGES PRIOR TO SHIPPING/RELEASE.

### CANCELLATIONS/RETURNS

ALL GOODS ARE CUSTOM MADE TO ORDER AND MAY NOT BE CANCELED AFTER 5 WORKING DAYS AND ACCEPTED MERCHANDISE MAY NOT BE RETURNED. SHOULD HUTTON COLLECTIONS MAKE AN EXCEPTION TO THIS RULE AND AGREE TO ACCEPT THE RETURN OF GOODS, A HANDLING CHARGE OF UP TO 50% OF THE NET SELLING PRICE MAY BE LEVIED. UNAUTHORIZED RETURNS WILL BE REFUSED AND RETURNED AT SENDER'S EXPENSE.

TEXTILES: IF BUYER WAIVES A CFA, THE GOODS ARE NOT RETURNABLE. ANY TEXTILE WHICH HAS BEEN CUT, TREATED OR PROCESSED MAY NOT BE RETURNED.

# SHIPPING & PACKAGING

AS A SERVICE TO DUR CUSTOMERS, HUTTON COLLECTIONS WILL ARRANGE THE SHIPPING OF ORDERS VIA DNE OF DUR PREFERRED CARRIERS. ALL CHARGES ARE PROFORMA AND WILL BE INCLUDED ON THE FINAL INVOICE. IF THE CUSTOMER CHOOSES TO MANAGE THEIR OWN FREIGHT AND DELIVERY, THE FEE TO MOVE THE PRODUCT TO A TERMINAL FOR "CUSTOMER'S OWN PICK UP" WILL BE ADDED TO THE FINAL INVOICE. IF CUSTOMER SELECTS THEIR OWN FREIGHT CARRIER, HUTTON COLLECTIONS IS NOT RESPONSIBLE THIRD PARTY FREIGHT CLAIMS.

HUTTON COLLECTIONS SHALL NOT BE RESPONSIBLE, IN ANY EVENT, FOR DAMAGE CAUSED TO THE MERCHANDISE DURING SHIPMENT, OR IN STORAGE. PURCHASER SHOULD REPORT SUCH DAMAGE DIRECTLY TO THE CARRIER.

RECEIPT OF PRODUCT: WHEN ACCEPTING DELIVERY, IT IS THE RECEIVER'S RESPONSIBILITY TO INSPECT THE ITEMS CAREFULLY. ANY DAMAGE OR EXCEPTIONS MUST BE NOTED ON THE TRANSPORTATION COMPANY'S FREIGHT BILL.

A SIGNATURE ON THE BILL OF LADING UPON RECEIPT OF THE PRODUCT CONFIRMS THAT THE PRODUCTS WERE RECEIVED IN GOOD CONDITION, UNLESS EXCEPTION IS MADE ON THE BILL OF LADING. FREIGHT CLAIMS MUST BE FILED BY THE RECEIVER DIRECTLY WITH THE CARRIER.



SHIPPING QUOTES ARE ONLY VALID FOR THIRTY DAYS. ANY FINAL INVOICES PAID AFTER THIRTY DAYS FROM THE INVOICE DATE MAY BE SUBJECT TO AN INCREASE IN SHIPPING CHARGES.

"PACKAGING" MAY REFER TO CARTONING OR BLANKET WRAPPING. IF CRATING OR ANY OTHER SPECIFIC PACKAGING IS REQUIRED, THE COSTS WILL BE ADDITIONAL.

IT IS THE PURCHASER'S RESPONSIBILITY TO MAKE SURE THAT ITEMS ORDERED WILL FIT THROUGH DOORWAYS, HALLWAYS AND SERVICE ELEVATORS.

ANY DUTIES, TAXES OR OTHER COSTS ASSOCIATED WITH INTERNATIONAL SHIPMENTS OUTSIDE OF THE UNITED STATES ARE THE RESPONSIBILITY OF THE PURCHASER.

### STORAGE

ADDITIONAL STORAGE FEES OF 3% PER MONTH WILL BE CHARGED FOR MERCHANDISE IF NOT PICKED UP WITHIN THIRTY (30) DAYS FROM THE DATE THE PRODUCT IS AVAILABLE FOR SHIPMENT.

DIMENSIONS PRINTED HEREIN MAY VARY DUE TO CRAFTSMANSHIP OR DESIGN REVISIONS. WE RESERVE THE RIGHT TO MODIFY DIMENSIONS AND/OR DESIGNS WITHOUT NOTICE.

ALL QUOTED COMPLETION AND DELIVERY DATES ARE ESTIMATES ONLY. HUTTON COLLECTIONS SHALL NOT BE RESPONSIBLE FOR ANY DELAY OR FAILURE IN PERFORMANCE FOR ANY CAUSE BEYOND HUTTON COLLECTION'S CONTROL (INCLUDING BUT NOT LIMITED TO INABILITY TO OBTAIN NECESSARY MATERIALS FROM ITS USUAL SOURCES OF SUPPLY, SHORTAGE OF LABOR OR RAW MATERIALS, TRANSPORTATION DIFFICULTIES, WAR, RIOTS, GOVERNMENT ACTIONS, ACCIDENTS, FIRES, ACTS OF GOD)
